Accommodations

Reservations must be made by Friday, January 3, 2025; please be advised that the block may sell out before this date. ICCFA's negotiated block rate is as follows: Monday, 2/3 = \$80 per night plus (not including tax or \$42 resort fee) Tuesday, 2/4 through Thursday, 2/6 = \$118 per night plus (not including tax or the \$42 resort fee).
